

ANTI-RAGGING COMMITTEE

The All India Council for Technical Education (AICTE), New Delhi vide its Notification no. 37-3/Legal/AICTE/2009 dated 25-03-2009 has taken a very serious view of ragging incidences in educational institutions and on Directions of the Honourable Supreme Court of India vide its Order dated 16-05-2007 has ordered strict implementation of rules & regulations for Prevention and prohibition of Ragging.

ROLES AND RESPONSIBILITIES:

1. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
2. To educate the students on the ill-effects of ragging and the consequences, including legal consequences of indulging in ragging.
3. To Prevent, Prohibit, and Redress any and all forms and instances of Ragging in the College.
4. To enquire into any instances of ragging that have been reported, and if necessary, take all appropriate action against the students found to have indulged in ragging.
5. To Set up a suggestion Box and place it in the college to help the students to drop complaints or any kind of problems.
6. To act against students violating the Anti Ragging Policy.
7. The Head of the institution shall be obliged to act immediately in response to the information received from the Anti-Ragging committee.
8. To conduct awareness programmes on the menace of ragging, its impact, consequences and redressal mechanism available.

PUNISHMENTS FOR THOSE FOUND GUILTY:

1. Debarring from appearing in any internal test or term end examination
2. Suspension from attending classes and academic privileges
3. Withdrawing scholarships and other benefits if any
4. Suspension from the college
5. Cancellation of the admission
6. Withholding the results.

7. Forfeiting campus placement opportunities/recommendations.
8. Imposing penalty in the form of fine.
9. First Information Report (FIR) will be filed with the local police authorities, on the direction of the Anti-Ragging committee
